### **DATA PROTECTION**

### NAME OF THE REGISTER

Korkia Group Marketing Register (hereinafter referred to as the "marketing register")

# **PURPOSE OF PROCESSING PERSONAL DATA**

Korkia processes personal data in the marketing register for the marketing of products and services. The processing of personal data is based on the Article 6 of the GDPR (1) Korkia's legitimate interest in providing and marketing Korkia's products and services to its customers (2) the legitimate interest of Korkia in carrying out direct marketing or (3) the customer's consent.

# WHERE IS PERSONAL DATA OBTAINED FROM?

Korkia acquires personal data primarily from the data subject himself or herself in the marketing register. In addition, Korkia acquires name and contact information from publicly and publicly available sources, such as the internet.

# TRANSFER AND DISCLOSURE OF PERSONAL DATA

The information in the marketing register is disclosed to the other companies of the Korkia Group. These entities are bound by the same obligations of confidentiality, processing of personal data and other obligations as Korkia. In addition, data obtained for marketing purposes may be disclosed to a third party in accordance with a separate data processing agreement.

# TRANSFER OF PERSONAL DATA OUTSIDE THE EU

Korkia does not transfer marketing register data outside the  $\ensuremath{\mathsf{EU}}.$ 

### **STORAGE OF PERSONAL DATA**

Korkia stores the information in the marketing register for an indefinite time or until the data subject prohibits direct marketing.

# **RIGHTS OF THE DATA SUBJECT**

The data subject has the right to:

- request access to the personal data of Korkia concerning him or her,
- request rectification, erasure, restriction of processing, object to processing or the right to transfer data from one system to another, and
- withdraw consent to the processing of personal data concerning him or her.

The data subject may send a request related to the exercise of these rights to Korkia in writing or electronically to the address indicated at the beginning of this Privacy Policy.

# **COMPLAINT TO THE SUPERVISORY AUTHORITY**

The data subject has the right to lodge a complaint with the supervisory authority. The Supervisory Authority in Finland is the Data Protection Ombudsman.
