DATA PROTECTION

NAMES OF REGISTRIES

Korkia Oy's stakeholder register, the register of partners and silent partners.

PURPOSE OF PROCESSING PERSONAL DATA

Register of stakeholders

Korkia processes personal data for communication and information between Korkia and its stakeholders.

Register of partners

The personal data of the partners is processed for the implementation, maintenance, management and development of cooperation between Korkia and the partners.

Register of silent partners

Korkia processes the personal data of silent companies for the purpose of implementing the personal data of silent companies and in connection with the maintenance and management of the investment. Korkia's legitimate interest relates to cooperation with the data subject, its preparation, development or termination, the analysis and development of Korkia's business, and communication with stakeholders and partners.

WHERE IS PERSONAL DATA OBTAINED FROM?

Korkia acquires the personal data of data subjects primarily from the data subject himself or herself, his/her representatives, public registers maintained by the authorities, publicly available sources and registers kept by external service providers.

WHAT IS THE BASIS FOR THE DISCLOSURE OF PERSONAL DATA?

If the processing of personal data is based on a contract with the data subject, the disclosure of personal data is a prerequisite for establishing a contractual relationship.

TRANSFER AND TRANSFER OF PERSONAL DATA

Data from the register of stakeholders, the register of partners and the register of silent partners are disclosed to the other companies of the Korkia Group and to the parties responsible for maintaining the customer data register and information systems. These entities are bound by the same obligations of confidentiality, processing of personal data and other obligations as Korkia. In addition, Korkia discloses information based on the law to various authorities, such as the Financial Supervisory Authority.

TRANSFER OF PERSONAL DATA OUTSIDE THE EU

Korkia may only transfer personal data outside the European Economic Area **(1)** on the basis of the customer's consent or **(2)** if Korkia has a statutory right or obligation to do so.

STORAGE OF PERSONAL DATA

Personal data processed in the stakeholder register, the partner register and the register of silent partners are stored for as long as their processing is necessary for the purposes of the collected personal data.

RIGHTS OF THE DATA SUBJECT

The data subject has the right to:

- request access to the personal data of Korkia concerning him or her,
- request rectification, erasure, restriction of processing, object to processing or the right to transfer data from one system to another, and
- withdraw consent to the processing of personal data concerning him or her.

The data subject may send a request related to the exercise of these rights to Korkia in writing or electronically to the address indicated at the beginning of this Privacy Policy.

COMPLAINT TO THE SUPERVISORY AUTHORITY

The data subject has the right to lodge a complaint with the supervisory authority. The Supervisory Authority in Finland is the Data Protection Ombudsman.
